To avoid being invoiced for services over and above what was supplied or for any errors in rate applications, it is the responsibility of users to advise Biarritz-Pays Basque Airport of any changes to their aircraft fleet, including purchase, sale, hire or any modifications to an aircraft's features.

In accordance with the recommendations of the "Commission Consultative Economique" of Biarritz-Pays Basque Airport, 17 November 2025.

Article 1:

The following terms and conditions along with the new rates excluding fee taxes shall be applied.

The conditions of establishment and collection as well as the new royalty rates applicable from April 1, 2026 are set as follows.

## I. BUSINESS AND PRIVATE AVIATION

### 1.Flat fees and handling tariffs applicable for general aviation non based aircraft (excl.tax)

The flat fee includes the fees for landing, parking (up to one hour, not to be split), passengers and lighting.

The handling tariff includes: Aircraft marshalling, chocks, access to the pilot lounge, passenger and baggage handling, weather/NOTAMS information, flight coordination. For aircraft from 4 tons and more, the handling includes as well, access to the VIP lounge for passengers, hotel reservations, taxis, tourist information.

Beyond 1 hour of parking, a parking fee will be charged, calculated per ton and per hour, and will be added to the flat-rate fee.

For the short-term hangar storage of aircraft weighing 2 tonnes or more, in hangar H8:

- A towing service fee applies, charged at a rate of 195,00 € excl. VAT for the aircraft's entry and exit.
- The assistance fee is increased by 50%.

The tariff for enabling airside access for people-carrying vehicles is invoiced at 162,50 € exc. VAT per access and per vehicle, upon the request of clients (companies, hotels, receiving agencies, etc.)

#### **Applicable reductions:**

Flights run by the French emergency medical services receive a 25% reduction on landing fees.

## **2. Fees applicable to based aircraft housed in individual hangar**

An aircraft is considered to be based if it is parked for more than 8 months of the year at the Biarritz-Pays Basque aerodrome and parking must be carried out in an individual hangar made available under the authorization regime. temporary occupation of the public airport domain. In addition, the aircraft must be declared by its owner to the services of Biarritz-Pays Basque Airport.

No fee reduction is applicable to the above rates.

Special provision applicable to aeroclubs holding an AOT:

For based flying clubs: a flat rate of 200 landings shall be applied per aircraft in the fleet of each of these flying clubs.

### **b. Handling GSE**

**Handling charges include:** landing fees, airfield lighting, aircraft marshalling/parking, chocking, towing, transfer of crew and passengers from/to the hangar, access to the pilot lounge, passenger and baggage handling, weather information, NOTAM briefings, and flight coordination.

**For aircraft weighing 4 tonnes or more, assistance also includes:** access to the VIP lounge for passengers, hotel and taxi bookings, and tourist information services.

In the absence of prior authorization (PPR) for parking, a flat fee of 100,00 € (excl.tax) will be invoiced in addition to other services and benefits.

## **V. SPECIAL CONDITIONS**

### **1. Liability**

Any person (natural or legal) operating at the Airport (whether or not contractually bound to the Airport) shall be liable for any damage of any kind caused either by themselves, their employees or agents, any person for whom they are responsible, or by their co-contractors or subcontractors operating at the Airport, and suffered by themselves, third parties, or the Airport (including the Airport's employees or agents).

In the event of damage suffered by a user, any potential liability of the Airport, regardless of the cause, shall be limited strictly to direct damage only and shall exclude consequential and non-consequential intangible losses, within the limits of the contractual caps of the Airport's Public Liability insurance policies.

With respect to ground handling operations, and in accordance with the International Air Transport Association Standard Ground Handling Agreement (IATA SGHA), in particular Article 8 relating to liability and indemnification, the Airport shall be liable, in the event of fault or negligence, only for direct physical damage to the aircraft and solely up to the amount of the standard deductible provided for under aircraft hull insurance policies, whether or not such insurance has been taken out by the aircraft owner or operator. In any event, this amount shall not exceed USD 1.5 million for any type of aircraft. No limitation of liability shall apply in cases of wilful misconduct, gross negligence, or intentional fault on the part of the Airport.

Aircraft or motor vehicles parked on Airport premises shall remain under the sole responsibility of their owner or custodian, the Airport not assuming the status of bailee or custodian.

Where an occupancy agreement for the use of the public airport domain has been concluded with the user, the liability provisions set out therein shall apply.

### **2. Waiver of recourse**

With respect to the damage referred to in paragraphs 1 and 2, any person (natural or legal) operating at the Airport (whether or not contractually bound to the Airport), as well as their insurers, shall:

- Waive any right of recourse against the Airport and its insurers, except in cases of gross negligence or wilful misconduct on the part of the Airport, which such person must prove. Gross negligence shall mean a fault of such seriousness as to demonstrate the party's unfitness to perform its obligations;
- Indemnify and hold harmless the Airport and its insurers, except in cases of gross negligence or wilful misconduct on the part of the Airport, against any claims of any nature whatsoever brought by any third party in connection with the aforementioned damage;
- Also indemnify and hold harmless the Airport and its insurers, except in cases of gross negligence or wilful misconduct on the part of the Airport, for all costs incurred in defending their interests in any existing or future dispute, including, but not limited to, legal counsel and representation fees, expert fees, and any unrecoverable legal costs.

### **3. Insurance**

Any person (natural or legal) operating at the Airport (whether or not contractually bound to the Airport) shall take out all insurance policies necessary to cover any risks, of whatever nature, that they may incur or cause as a result of their use of the Airport, including in particular property damage insurance covering assets belonging to the user and a public liability insurance policy covering risks of damage to third parties, with coverage limits adequate in view of the risks inherent in an airport environment.

The insurance policies taken out by any person (natural or legal) operating at the Airport shall incorporate the waiver of recourse provisions set out in Article IV.2 above.

Where an occupancy agreement for the use of the public airport domain has been concluded with the user, the insurance provisions set out therein shall apply.

### **4. Required Documents for Aircraft Operations**

In the month preceding the aircraft's arrival for scheduled airlines or before invoicing for general and business aviation, the following documents must be submitted to the airport:

- Certificate of Airworthiness indicating weight specifications.
- Noise Certificate specifying the maximum takeoff weight, engine details, and associated noise measurements.
- Air Operator Certificate (AOC) listing the relevant fleet to determine the type of commercial flight operation.

If applicable, for French airlines, a company-issued certificate confirming that the majority of their traffic is international (for VAT exemption purposes).

- The VAT number of the airline/operator.
- For EU-based companies, the intra-community VAT number.

If these documents are not provided, invoices will be issued inclusive of VAT, and no retroactive credit notes will be granted.

Non-certified declarative lists from the aviation authority of the country of origin will not be accepted.

### **5. Invoices payment**

Charges and service fees are, in principle, payable immediately in cash by all companies and individuals, upon presentation of an invoice statement and issuance of a receipt. However, an application to open a customer account may be submitted to the Airport operator.

The opening of an account may be considered where:

- the invoiced operations are of a recurring nature;
- the amounts invoiced are sufficient to justify maintaining an account;
- the operator provides adequate guarantees regarding payment of invoices.

Surcharge for failure to pay in cash: if a company or individual without a customer account fails to pay the charges and service fees immediately in cash, a fixed additional amount of €20 excluding VAT shall be applied, in addition to the aforementioned billing fees.

## **6. Methods of payment**

Payment may be made by the following methods:

- By cash.
- By bank or postal check, including Eurocheques, made out to « SGC Côte Basque/ trésor public ».
- By Visa bank card or AMEX for pour business and private aviation

## **7. Payment deadlines**

Our invoices are payable within 30 days at most from the date the invoice was issued without discount.

## **8. Late payment**

In the event of late payment, the payer owes the Joint Association a late fee as well as a fee for debt collection costs.

The interest rate for late fees is equal to 3 times the legal interest rate. The fee for collection costs is set at 40 euros.

## **9. Ground holding**

Regardless of the penalties incurred for late payment and of the fee for debt collection costs, the act of passing an unpaid aeronautical invoice to the claims department triggers the implementation of the procedure as provided for by Article R.224-4 of the French Civil Aviation Code below:

Fees are due for the provision of personnel and/or the use of the facilities, installations, buildings and tools that they cover the cost of.

In the event of the non-payment of fees due by an aircraft operator, the airport operator is permitted to call for the relevant authority of air traffic at the airport to hold the aircraft until the disputed amount has been received".

## **10. Application**

These tariffs are applicable from the First of April 2026.

From this date, all conflicting provisions which may have been contained within texts previously in force shall become null and void.
